I understand that it is my responsibility to notify the Marysville Police Department in writing within ten (10) days when a change in the above information occurs.

I also have read, understand, and agree with the following information and fees regarding false alarms:

If any alarm system produces three (3) false alarms in any twelve (12) consecutive month period, written notice of that fact shall be given by regular mail or delivery to the subscriber.

If more than three (3) false alarms are produced by any alarm system in a twelve (12) month period, an administrative fee of fifty dollars (\$50.00) shall be assessed against the alarm user for the fourth false alarm, and an administrative fee of one hundred dollars (\$100.00) shall be assessed against the user for the fifth false alarm, a fee of two hundred fifty dollars (\$250.00) shall be assessed against the user for the sixth false alarm, a fee of five hundred dollars (\$500.00) shall be assessed against the user for the seventh false alarm. Such charges shall continue for each successive false alarm until six (6) consecutive months have elapsed during which time no false alarms have been recorded. At that time the record will be cleared, and the next false alarm shall be deemed to be the first such incident. These fees shall be in addition to any criminal penalties imposed under Section 733.00099. Such charges shall continue for each successive false alarm until six (6) consecutive months have elapsed during which time no false alarms have been recorded. At that time the record will be cleared and the next false alarm shall be deemed to be the first such incident.
