The driver then Exited back onto Delaware Ave from US 33 towards downtown. The pursuit was terminated due to the vehicle entering the downtown area of the city. Officers were able to track the vehicle due to gouge marks left in the pavement from a damaged tire on the vehicle. The vehicle was then observed on N Main St driving across US33 to SR 31 where it was lost due to construction area traffic. The driver was located a short time later changing his tire behind a business on SR31. The driver fled on foot into the Mill Valley subdivision where he was apprehended by officers.
